

## Financial Affidavit for International Students on F-1 Visas

To receive an F-1 or J-1 visa, applicants must provide evidence that they have sufficient funds to cover their first year of study in the U.S. Costs indicated on the table are for standard undergraduate and graduate programs. Some graduate professional programs, such as MBA and credential, require higher tuition. Please refer to the program website for cost information if you are enrolling in a graduate professional program.
