Your Enrollment Reservation Deposit (\$50), when received, will be credited towards your Spring mandatory registration charges and will therefore reduce the charges when you complete registration.

This Enrollment Reservation Deposit (ERD) does not guarantee specific course or program availability and the Mandatory Orientation fee does not guarantee a specific orientation date.
